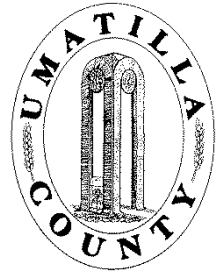

GENERAL DESCRIPTION OF POSITION

The UCo Health Clinic's located in Pendleton and Hermiston provide affordable and accessible healthcare services to Umatilla County residents that includes immunizations, sexually transmitted infections, and reproductive health. These clinics help to ensure a healthy Umatilla County population.

The Nurse Practitioner at the UCo Health clinics provides assessment, evaluation, and treatment for clients seeking reproductive health services and sexually transmitted infection testing and treatment. Working in partnership with public health nurses the NP works to address the client's needs including connecting clients to a primary care provider and other community resources.

SUPERVISORY RELATIONSHIPS

Works directly under the supervision of the Deputy Director and in consultation with the Public Health Officer. Retains discretion allowed by license for operations UCo Health clinic work. Provides medical guidance to public health clinic nurses regarding care of UCo Health clinic clients.

PRINCIPAL DUTIES OF POSITION

- Obtain medical, social, emotional and developmental history as appropriate (EE).
- Perform comprehensive or focused physical exams (EE).
- Order appropriate screening and diagnostic studies (EE).
- Keep complete and accurate records in the patient's chart (EE).
- Consult/collaborate with physicians and other allied professionals (EE).
- Determine if referrals are needed (EE).
- Prescribe medications and treatments according to established standards of care (EE).
- Provide patient education and instructions regarding medications, treatment plans, and health maintenance (EE).
- Document all care provided in an Electronic Health Record system (EE).

OTHER DUTIES OF POSITION

- Participate in and collaborate with the UCo Health Clinic team (EE).
- Participate in and assist with Reproductive Health Certification process (EE).
- Other duties as assigned (EE).

REQUIREMENTS FOR POSITION

Minimum Requirements

- Current and unencumbered Oregon Nurse Practitioner and Registered Nurse licenses.
- Graduation from an accredited graduate-level program with a Master's of Science in Nursing.
- Board certified, family or women's health specialty.
- 2 years of experience as a practicing Nurse Practitioner.
- Ability to communicate effectively.
- Possess a valid driver's license with a satisfactory driving record or ability to obtain within 30 days of employment.
- Must successfully pass a background check and drug screen

Preferred Qualifications

- Family Nurse Practitioner (FNP).
- Graduation from an accredited graduate-level program with a Doctorate of Nursing Practice preferred.
- Experience with reproductive health.

SPECIAL QUALIFICATIONS

PHYSICAL DEMANDS

While performing the duties of this job, the employee works in an office environment; the employee rarely works in outside weather conditions. The noise level in the work environment is usually quiet.
